Thus, the top tax rate applicable to capital gains is 20% versus the top tax rate for ordinary income of 39.6% as described earlier Under Trump's tax plan the capital gain rates remain the same: 0%, 15%, and 20% However, within Trump's lowest income tax bracket, the 12% bracket, the capital gains rate could be 0% or 12%
